

# Good Shepherd Fairview Home Visitation Fact Sheet

- Visitors and residents must comply with Social distancing, hand hygiene, and wear disposable face masks at all times. All masks must be discarded upon exiting the grounds.
- Visitors must be screened prior to the visit, including temperature checks.
- **Visitors for SNF residents only must have a negative COVID-19 test within the last 7 days from the scheduled visit.**
- Good Shepherd will not permit any in room visitation unless resident is receiving end of life care in skilled nursing or a skilled nursing resident is bedbound and it is unsafe to transport the resident to the designated visiting area. (This will be on a limited basis only in conjunction with virtual visits)
- All visitation will take place outdoors, weather permitting. Only under certain limited circumstances will visitation be allowed inside in a well-ventilated space with no more than 10 individuals who are appropriately socially distanced and wearing facemask. (i.e. inclement weather at the time of a scheduled visit, outdoor temperatures less than 50 degrees).
- At no time shall the total number of visitors exceed 10% of the in-house resident census.
- Visits are by appointment only and are limited to 30 minutes.
- Visitors must be 18 years of age or accompanied by an adult 18 years of age or older.
- Documentation on visitors name, address, phone, and e-mail is required.
- Good Shepherd reserves the right to refuse any visitor who refuses to be compliant with any aspect of the visitation guidelines or is under the influence, disruptive or presents a danger to any resident or staff.

  - Mondays-10 a.m. -12 p.m. and 4p.m. to 6 p.m.
  - Wednesdays- 10a.m. to 12 p.m. and 2p.m. to 6 p.m.
  - Thursdays-10 a.m. to 12 p.m.
  - Fridays-10 a.m. to 12 p.m. and 4 p.m. to 6 p.m.
  - Saturdays- 10a.m. – 12

❖ In the event of any staff and/or resident cases of Covid-19 at the facility, visitation will be suspended until further notice.

**Hand Hygiene:** Whether you use soap and water or hand sanitizer, rub your hands together for at least **20 seconds**.

**Use hand sanitizer if soap and water are unavailable**

1. Apply the recommended amount of gel to the palm of one hand.
2. Cover all surfaces of the hands and fingers.
3. Rub the hands together for **approximately 20 seconds**.

## Proper way to wear mask



*Wear a mask that covers your nose and mouth to help protect others in case you're infected with COVID-19 but don't have symptoms*

- Wear a mask in public settings when around people who don't live in your household, especially when it may be difficult for you to stay six feet apart
- Wear a mask correctly for maximum protection
- **Don't** put the mask around your neck or up on your forehead
- **Don't** put the mask below your nose or chin.
- **Don't** touch the mask, and, if you do, wash your hands or use hand sanitizer to disinfect
